4.1 Description of first-aid measures

5. Fire-Fighting Measures

5.1 Extinguishing media

5.2 Special hazards arising from the substance or mixture

Special Hazard

Most vapors are heavier than air. They will spread along ground and collect in low or confined areas (sewers, basements, tanks) Vapors may travel to areas away from work site before igniting/flashing back to vapor source Thermal decomposition can lead to release of irritating gases and vapors

5.3 Advice for firefighters

Evacuate personnel to safe areas. Move non-burning material, as feasible, to a safe location as soon as possible. As in any fire, wear self-contained breathing apparatus pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear. Cool containers with flooding quantities of water until well after fire is out. Thoroughly decontaminate all protective equipment after use. DO NOT extinguish a fire resulting from the flow of flammable liquid until the flow of the liquid is effectively shut off.
