4. First-aid Measures

Description of first-aid measures.

General advice.

Move victim to a safe isolated area. Immediate medical attention is required. Call a poison control center or doctor for treatment advice.

Inhalation.

Move to fresh air. Apply artificial respiration if victim is not breathing. Call a poison control center or doctor for treatment advice.

Skin contact.

Wash off immediately with soap and plenty of water. Remove all contaminated clothes and shoes. Remove and wash contaminated clothing before re-use. Call a poison control center or doctor for treatment advice.

Notes to physician.

Treat symptomatically. Smallest quantities reaching the lungs through swallowing or subsequent vomiting may result in lung edema or pneumonia.

5. Fire-fighting Measures

Extinguishing media.

Suitable extinguishing media.

Use:. Dry powder. Alcohol-resistant foam. Carbon dioxide (CO₂). Water may be used to cool and prevent the rupture of containers that are exposed to the heat from a fire.

Extinguishing media which shall not be used for safety reasons.

Special hazards arising from the substance or mixture.

Vapors may travel to areas away from work site before igniting/flashing back to vapor source. Thermal decomposition can lead to release of irritating and toxic gases and vapors. Most vapors are heavier than air. Vapors may spread along ground and collect in low or confined areas (sewers, basements, tanks). Vapors may travel to source of ignition and flash back. 6. Accidental Release Measures

Personal precautions.
